Actual status	Running
Approach	The APROFOMO project (funded by measure 124 of the Tuscany Regional RDP) has developed, among other products, a specification for forestry companies (APROFOMO disciplinary).  By signing this regulation, companies undertake to operate in a more sustainable regime.  The guarantees provided by these companies are therefore:  • the legality of the products supplied; • compliance with current safety regulations; • true commitment to protecting and safeguarding the environment; • the traceability of wood materials (Reg. 995/2010).
Main results	At the moment, 13 companies have signed up to the APROFOMO disciplinary.  Awarding mechanisms have been applied to favor these companies over others in particular:  • adoption of a reward score for the companies participating in the auctions organized by the Union of Municipalities of Valdarno and Vadisieve;  • exclusive of cuts in the woods managed through the "woodland turnkey" project;  • exclusive presence on the website <i>FMMF wood</i> • creation of contacts with the next links in the supply chain that require FMMF branded wood.



Lessons learned	This project has tried to improve the level of forestry companies present in the FM area and in the neighboring ones.  The companies have had the opportunity to compare themselves with the forest instructors of the "forest training center of Rincine" by improving their abatement techniques, better understanding the importance of a job done safely, learning the regulatory changes at a regional, national and European level.
